The meeting was called to order at 6:00 p.m.

SOLID WASTE/RECYCLING CONTRACT

The Board signed the Gauthier Trucking contract for solid waste and recycling services.

ROAD SCHEDULE

Dave Tilton discussed the secondary access on Ron Frey's property on Old Stage Road. The access was put in because he couldn't access that part of his property without tearing down a stone wall. Ron Frey would like to meet with Gary to discuss the ditching on Old Stage Road.

Gary has received a request to trim brush on Westford Milton Road to improve site distance. The brush is outside of the roadside mowing area and on the requestor's neighbor's property. The Town has not cut brush around driveways, only road intersections. The Selectboard suggested the resident contact their neighbor about trimming the brush.

Bob Bancroft made a motion to approve the Road Schedule for June 29, 2009 through July 10, 2009, seconded by Dave Tilton. Motion passed: 3-0.

BILLS/CORRESPONDENCE

Bills were approved, correspondence was read.

FY'09 BUDGET

The Board reviewed status of the FY'09 budget. Charlotte advised that there is approximately \$11,000 left over. Gary would like to purchase some items totaling approximately \$4,500.

Bob Bancroft made a motion to approve the purchases requested by Gary, seconded by Dave Tilton. Motion passed: 3-0.

MINUTES

Bob Bancroft made a motion to approve the minutes of June 11, 2009 as written, seconded by Dave Tilton. Motion passed: 3-0.

FEE SCHEDULE

Bob Bancroft made a motion to approve the amended Fee Schedule to reflect the new recording fees effective July 1, 2009, seconded by Dave Tilton. Motion passed: 3-0.

The Zoning Administrator is questioning the fee for duplexes; it is the same as single family dwellings. The fees were calculated on staff time spent on the various applications. The Board would like Maurice Rathbun and Melissa Manka to provide the Board with an update calculation for staff time, as well as what other towns charge. This will be discussed again in October.
