ZONING ENFORCEMENT LETTER

The Selectboard reviewed and approved the most recent draft of a zoning enforcement letter. The letter was designed for property owners who received a violation notice but have come into compliance. The letter offers a settlement offer rather than pursuing a fine through Environmental Court in an attempt to recoup the Town's costs.
